

**St. Martin-in-the-Fields High School for Girls Governing Board as at 18 June 2018**

The school is an academy and therefore a charitable company. It currently has three 'members' who appoint most of the governors upon nomination by others. Governors are directors as well as trustees. How the Governing Board should be made up is set out in the company's Articles. Terms of office are for 4 years except for ex officio<sup>1</sup> posts or as stated.
