# Policy

The RSE policy includes the following information:

- How the programme is taught
- How religious backgrounds of pupils are taken into account
- How SEND students are supported before, during and after PSHE lessons
- How sensitive topics are approached
- When sex education is taught including clarity for parents on the right to withdraw
- Reference to any requirements on schools in law e.g. the Equality Act
- When the policy will be updated and who approves it
- Topic specified by the DFE are attached as an appendix to the policy

#### **Planning for implementation**

•From September 2020 the Statutory Guidance becomes a requirement and will apply to all schools in all the relevant year groups

•Our Head of Wellbeing has attended a number of different workshops and Government led training days to ensure we are up to date and working in the right way to provide the highest quality PSHE curriculum

•We are currently adapting the curriculum to ensure that it is up to date with the new guidance and requirements





# What is age-appropriate?

- The use of the PSHE Association Programme of Study is supportive of guidance towards age-appropriate delivery
- This means that we consider this guidance and teach topics that we believe, through our experience with our students, is appropriate for them to learn about
- For example in Sex Education we teach about consent and the law regarding consent in Year 9
- We feel Year 7 or Year 8 is too early and for Year 10 students this might surpass the requirement at this age
- Parent/carer views will be taken into consideration via the consultation process

# **Curriculum links**

For all of our topics we will establish firm links between curriculum based learning and learning in Wellbeing. We will invite students to make that link where possible.

For example; the reproductive system is studied in Biology and also in some elements of Wellbeing. We will encourage students to apply their theoretical knowledge gained in other subjects in order to better understand the context used in Wellbeing.



#### LGBT inclusive education

DfE statutory Guidance says:

"Schools should ensure that all of their teaching is sensitive and age appropriate in approach and content. At the point at which schools consider it appropriate to teach their pupils about LGBT, they should ensure that this content is fully integrated into their programmes of study for this area of the curriculum rather than delivered as a stand-alone unit or lesson. Schools are free to determine how they do this, and we expect all pupils to have been taught LGBT content at a timely point as part of this area of the curriculum".

# LGBT inclusive education

- The statutory guidance states that all pupils should receive teaching on LGBT relationships during their school years. The guidance is clear that secondary schools should include LGBT content in their teaching
- Awareness of LGBT issues is covered through assemblies, tutor activities and other areas of school life as well as in the Wellbeing curriculum



#### **Dealing with sensitive issues**

Staff who deliver the RSE curriculum will receive bespoke training

General principles include:

- Whole class discussions can be a useful way to model listening respectfully to the views of others and turn-taking
- Teachers should manage and lead discussions attentively. If the discussion is at risk of straying, the teachers need to be prepared to redirect it back to intended topics
- It is generally not helpful to ask pupils to lead or chair discussions on sensitive topics as there can be a greater risk of going off topic

#### Assessment and evaluation

- To assess Wellbeing (including RSE) we have developed a short question paper for each topic
- Students will sit their question paper at the end of every topic
- Students will mark their work using a mark scheme
- Students will give feedback to their peers on their answers
- Progress will monitored and attitude to learning fed back to parent via the school's usual reporting process
- Any concerns will be dealt with via the school's existing systems

#### Advice for supporting students at home

Ideas for engaging with students at home

•Discuss topics over dinner

•Ask open questions not leading ones "What did you learn today in Wellbeing?", "Did you hear any words you don't understand?", "Did anything worry or concern you today? Would you like to talk about it?"

- •Drawing or mind mapping what was learnt
- •Writing a statement of learning
- Presenting ideas
- Showing resources

#### Statutory and non-statutory guidance

<u>Statutory Relationships Education, Relationships and Sex Education and</u> <u>Health Education guidance</u> – schools will be required to have regard to this from September 2020

<u>Current SRE (2000) guidance</u> – schools can teach to the new subjects but must continue to have regard to the SRE guidance until September 2020.

Guides for parents and FAQs

<u>Teaching online safety in schools</u> - new non-statutory guidance which aims to support schools in teaching pupils how to stay safe online within new and existing school subjects, such as Relationships Education, Relationships and Sex Education, Health Education, Citizenship and Computing.
